Let's Talk About Timesheets!

- 1. If your timesheet is illegible, and your PC or HR is unable to read it, you will be called to the office to redo it. If you have any questions on how to fill out your timesheet, please get with your House Manager, PC or with Bonnie in HR. They will be glad to help you.
- 2. If your total time at the bottom of the timesheet does not add up or if you do not sign your timesheet in the appropriate space, you will be called to the office to make the necessary corrections.
- 3. Do not PRE-fill out your timesheets. Fill out your timesheet every single time you work. If you PRE-fill out your timesheet and you don't work all of the hours listed on your timesheet, you will be called to the office to make the corrections.

Just remember: If the timesheets have been submitted to the office for processing and you are contacted to correct or sign your timesheet, you will be required to make the necessary corrections in the office. Timesheets will not be sent to the Payroll Department for payment until corrections have been made.

Medication-Heat and Sun Protections Overheating

The body needs to maintain a relatively consistent temperature to function properly, about 98.6 degrees Fahrenheit. Some medications, like antipsychotics, may impair the body's ability to regulate temperature which can lead to elevated body temperature and medical emergencies of hyperthermia, heat exhaustion or heat stroke. Other medications may increase urination, decrease thirst, or decrease sweating which may in-crease risk of dehydration. It is important to take precautions during hot or humid weather and during physical activity to reduce the risk of excessively elevated body temperature.

Strategies for Protection

- Talk to the prescribing physician and pharmacist if you have concerns.
- During the head of the day, try to keep cool by avoiding overexertion, keeping windows or shades shut, or by moving to cooler rooms.
- Use air-conditioned vehicles for transport. Eat regular meals, drink plenty of fluids, and avoid coffee, tea or alcohol.
- Dress in loose-fitting, light colored clothing. Take periodic rests in air-conditioned areas and seek shade during outdoor activities.





NOTES FROM THE TRAINING COORDINATOR

- Employees need to fax or bring a copy of their training certificates and/or In-Service sheets to the office once their training is completed.
- Employees need to make sure that FPH receives an updated copy of their auto insurance once it has been renewed, insurance company has changed, or whenever they get a new vehicle.
- Employees must bring in a copy of their new Driver's License once it has been renewed. Without a current copy on file, employees will be pulled from the schedule until this has been taken care of.
- If employees are unable to attend trainings or in-services for any reason, they MUST contact their PC and/or Training Coordinator.

TORNADO SEASON IS HERE!

A tornado is a violently rotating column of air extending from the base of a thunderstorm to the ground. Tornados can happen anytime of the year but prime conditions occur in Oklahoma from late March and can go through as late as August. During tornado season it is important to be prepared!



Know the Difference between:

Tornado Watch and a Tornado Warning

Watch: Tornadoes are possible in and near the watch area. Review and discuss your emergency plans, and check supplies and your safe room. Be ready to act quickly if a warning is issued or you suspect a tornado is approaching. Acting early helps to save lives.

Warning: A tornado has been sighted or indicated by weather radar. Tornado warnings indicate imminent danger to life and property. Go immediately to your safe place (underground to a basement, storm cellar or an interior room such a s a closet, hallway or bathroom).

Fretzpark Homes Employee Referral Program

Do you happen to know someone that is in need of a job and working with developmentally disabled individuals would be a good fit for them? Send them to the office to fill out an application. Make sure they know to put your name down as someone that referred them and if they are hired, you will be compensated.

After their first <u>full week</u> on the job, you will receive a direct deposit posted to your payroll account in the amount of **\$50**.

After their first 90 days of employment with FPH, you will receive an additional Direct deposit to your payroll account in the amount of **\$100**.

FPH Question and Answer Section:

- Q: How many hours per week do I need to work in order to receive medical, dental, and life insurance benefits?
- A: For Medical and Dental Insurance, employees must be scheduled to work a total of 24 hours per week in order to qualify for benefits. For Company paid Term Life Insurance, employees must be scheduled to work 30 hours per week.

FPH Policy Reminders

Any scheduled training classes such as MAT, CPR/FA, College of Direct Support, etc., that employees are scheduled to attend and miss for any reason will pay the fees that are charged to FPH. Missed class fees that are assessed by the different training locations are typically \$35. If you miss 2 or more classes, not only will you be assessed the fees, you will be taken off of the schedule until the training is complete. Please notify Jamesetta Lewis, Training Coordinator, if you will be unable to attend scheduled training.
